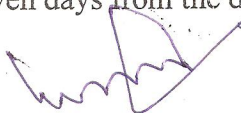

Registration Certificate

The General Secretary, International Society for Human Welfare and Rehabilitation (ISHWAR), A-4, Naraina Industrial Area, Phase-1, New Delhi-110028 (hereinafter called the holder of certificate of registration) is hereby granted certificate of registration to establish/maintain the aforesaid institution during the period 8/2/2012 to 7/2/2018 (both days inclusive) subject to the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act, 1995 and the rules and orders made there under and to the following conditions, namely :-

1. The holder of Certificate of Registration shall provide the inmates of the institution with:-
 - (u) Wholesome and sufficient food.
 - (v) Adequate housing accommodation sanitary in conditions.
 - (w) Proper medical care and treatment.
 - (x) Facilities for recreation.
 - (y) Literary education and vocational or professional training.
2. Residential premises for girls shall be separate from residential premises for boys.
- (3) The holder of Certificate of Registration shall not employ or shall allow other to employ an inmate of the institution for any private purposes whether of his own or others.
- (4) The holder of Certificate of Registration shall maintain a punishment register and shall record therein when occasion so arise:
 - (m) The name of the inmate,
 - (n) The reasons for the punishment,
 - (o) The nature and extend of the punishment.
- (5) The Manager shall maintain a visitor's book, which shall contain the records of visit to the institution by the licensing authority or any person authorized by it to inspect the institution. The Manager shall furnish to the licensing authority a copy of remarks if any recorded in the said book within seven days from the date of visit.

- (6) The Manager shall maintain account book of income and expenditure and stock books of consumable articles in such form and such other books and registers, if any, as may be prescribed by the prescribed authority from time to time and shall produce them.
- (7) The holder of Certificate of Registration shall provide every facility to the Competent Authority or any person authorized by in it the behalf for making inquiry order and in accordance with provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights & Full Participation) Act, 1995.
- (8) The certificate shall be exhibited in a conspicuous place in the office of the manager.
- (9) Any change in the office bearers shall be immediately intimated to the Competent Authority.
10. The Certificate of Registration shall abide by the conditions of this Certificate of Registration and the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 and the rules and regulations and order made there under:
